As people are living longer worldwide, clinicians will increasingly need the skills and knowledge to work with older adults. Professional guidelines indicate that specific competencies are needed to work effectively with older clients, yet many clinicians surveyed say they have not had sufficient training and experience to work with this client population. She currently provides assessment, intervention, and consultation in a primary care setting and is a faculty member of an internal medicine residency program.
